# **2019 Spring Tri-Club Queens Pageant**

## **Contest Rules and Requirements**

**STC Pageant Committee Chairmen:** Laurie Fitzmorris and Brandy Moorhead

**Ages:** Open to females in the 3<sup>rd</sup> through 12<sup>th</sup> grades. Applicants must live within the Spring ISD boundaries, be a member in good standing of a Spring ISD FFA, FCCLA or Spring 4-H organization to be eligible to participate in the Spring Tri-Club Queens Pageant ("STC Queens Pageant").

**Entry Fee - \$25:** Competition fee can be check, money order or cashier's check made payable to Spring Tri-Club. Fees will not be refunded for no-shows.

### **Divisions:**

Fair Princess	3 <sup>rd</sup> – 8 <sup>th</sup> Grades
Jr. Fair Queen	9 <sup>th</sup> -11 <sup>th</sup> Grades
Queen	12 <sup>th</sup> Grade

**Number of Contestants:** The Contest will automatically close when 30 entries per Division have been accepted. Deadline for entry is Wednesday, January 16, 2019. In the event an entry form arrives after the Contest has been declared closed, the applicant will be notified and the entry fee will be returned. Entries must be mailed to Spring Tri-Club, P.O. Box 162, Spring, TX 77383 and postmarked by January 16, 2019.

**Outfit:** Contestants will be able to express their personality by wearing an outfit of their choice. Points will not be given for the outfit, but should be age appropriate and tasteful. Western attire recommend - jeans or skirt and boots. All garments must be school appropriate.

## **Contest Requirements**

Contestants must be female and may not be married, pregnant or have been charged or convicted of any crime. Queens may not use alcohol or tobacco in any form. Zero tolerance policy will be enforced and should a situation arise may result in disqualification.

Contestants and Pageant winners must be of good moral character, set high standards and judgments, serve as a positive role model for all exhibitors and the Spring community. If Contestants or Pageant winners are deemed to participate in inappropriate comments, immoral or indecent acts or behavior in any way, including but not limited to social media, that candidate will be ineligible. This includes unseemly and/or offensive photos, video or written comments.

Any STC Queens Pageant winner who has relinquished a title by choice or who is removed by the STC Pageant Committee, will be barred from participating in any

future STC Queens Pageants. If a STC Queens Pageant winner is removed from her position, she is to return the Crown and Sash to the STC Pageant Committee immediately following removal.

Contestants must be academically passing. Spring Tri-Club eligibility forms are due by January 16, 2019 and are coordinated through the FFA, FCCLA and Spring 4-H Advisors.

Failure to attend and compete at all judged and required events will result in disqualification and loss of competition fee. Promptness is essential.

Queen Candidates must agree to be personally interviewed by the judges and understand that the decision of the judging panel is final. Scores remain the property of Spring Tri-Club. Jr. Fair Queen and Fair Princess Candidates will have a thought question on stage during their walk.

Any individual having been crowned Jr. Queen or Fair Princess cannot hold consecutive titles in those Divisions.

Family members and friends are invited to attend the Contest. There is no admission fee. Light refreshments will be sold.

Any contestant, parent, or guest demonstrating poor sportsmanship, argumentative behavior, etc. will be asked to leave the event. If it is the contestant, she will be disqualified.

### **Fair Princess, Jr. Fair Queen and Queen Responsibilities**

Fair Princess, Jr. Fair Queen and Queen will assist the Ring Stewards during each Livestock Show with duties assigned by the Ring Stewards, such as distributing ribbons, etc. The 2019 Spring Livestock Show & Fair Schedule of Events is available at [www.SpringTri-Club.org](http://www.SpringTri-Club.org)

Fair Princess and Jr. Fair Queen will be photographed with all Reserve Grand Champion Winners and their Award Sponsors. The Fair Queen will be photographed with all Grand Winners and their Award Sponsors.

The Fair Princess, Jr. Fair Queen and Queen will be responsible for working the Live Auction on Saturday, March 30, 2019. This includes securing Buyer information after the bid is won and coordinating Buyer with the Exhibitor and any other assigned duties. Official Tri-Club dress is required during the Live Auction along with crown and sash.

Except when showing or preparing to show their own projects, or during the Live Auction, the Fair Princess, Jr. Fair Queen and Queen must comply with the following dress code at all times during the Spring Livestock Show & Fair:

Awarded Sash and Crown

Western Attire

No visible tattoos or body piercings (exception of ears)

No shorts or sandals

Hair, makeup and overall appearance should be age appropriate

\*\*\*Only Spring Livestock Show & Fair related scheduling conflicts approved by the STC Pageant Committee will be allowed.\*\*\*

At the discretion of the STC Pageant Committee, a potential scholarship could be awarded to the Queen.

### **Acknowledgement and Release of Liability:**

In the event of a natural disaster or other unavoidable event, STC Pageant Committee may change the dates and times of the contest. It is the responsibility of the Candidates to provide the STC Pageant Committee with at least two valid telephone numbers, mailing address and appropriate e-mail addresses at which they can be reached.

The STC Pageant Committee reserves the right to make additional rules, regulations and amendments as necessary. Decisions by the STC Pageant Committee are final.

This event should be fun for everyone and can be a learning experience. The STC Pageant Committee will not tolerate any questionable behavior, false accusations about other contestants or cheating of any sort.

I certify that I have read and understood all of the rules stated in the STC Queens Pageant Rules. Both Candidate and Parent/Guardian, by signing below agree that they have carefully read and fully understand all of the provisions of this document, they accept and agree to abide by the terms of this document, and they knowingly and voluntarily execute this document.

or property damage, accrued or to accrue in the future, known or unknown, relating to or arising out of and negligent, grossly negligent, and/or intentional acts on the part of the undersigned in connection with the undersigned's entry into and participation in the activities. The undersigned also agrees to defend, indemnify and hold harmless the Spring Tri-Club, Spring ISD and its legal representatives from any and all claims.

#### **Interview:**

Queen Contestants will be given a number at check-in and must be interviewed in that order or forfeit their turn. Each Contestant will have a 2-5 minute interview with the judges. Only Contestants will be allowed during this portion. Interviews will take place in the teaching theatre at Spring High School.

#### **Pageant:**

**Spring Tri-Club History**

In 1950, Spring ISD was a small district and the Ag Department did not have an adequate number of students to have a project show. Mr. L.C. Nagy, a local Dairy farmer, had an idea of combining the FFA, 4-H and FHA (the name changed to Family Careers and Community Leaders of America – FCCLA in 1999) organizations together to provide enough participation to have a project show. Mr. Nagy then called Avalt Meyer, John Nagy Jr., W.E. Murphy, Cliff Dozier, W.R. Booth, Bud Dueitt, Henry Theiss and many more community members and asked if they would be interested in helping. From that day forward, history was made. The name Tri-Club was given to the organization to symbolize the merging of the three clubs to form one show for Spring ISD known as the Tri-Club Show.

In April of 1951 the first Tri-Club Show was held on the L.C. Nagy farm located on Interstate 45. Mr. Nagy along with other community leaders organized the festivities that included a Talent Show, Pet Show, Hay Ride, Queens Contest, Barbecue and the Project Show. The majority of the animals shown at the first show were donated to the students by Mr. Nagy and other local farmers. Mr. Nagy's vision for the calves was for the students to take a calf and raise it to the very best of their ability. The main purpose was to teach the students how to raise an animal, learn responsibility and showmanship.

In 1974 a logo was designed for the Tri-Club Show which consisted of a large triangle with the emblem for each organization in each point. On March 10, 1983 the first show was held at the L.C. Nagy Pavilion located on Lemm Road 1. The Spring Livestock Show & Fair is still held at this location.

As time passed and the rural area began to change, the Tri-Club Show also began to change. The Talent Show, Pet Show, Queens Contest, Hayride and all night Barbecuing was discontinued. The Tri-Club organization began awarding scholarships to those deserving graduating Seniors. A Silent Auction started for the Arts, Crafts, Visual Arts, Photography, Horticulture and Food Divisions.

Since the first show, the Spring Tri-Club organization has reached many levels and has maintained a quality of excellence in leadership. The success and growth of this organization and Show can only be attributed to dedicated Parents, Leaders, Community Support and students with a love for Agriculture and homemaking as it is today.
